

ExpoSports 2025 is the preliminary step to the Zurich Marató de San Sebastián. The fair will take place at the Kursaal Conference Centre.



Provision of parking spaces.



BOOKING CONDITIONS

Once the form has been received, the organisers will send the corresponding invoice by e-mail to the exhibitor, who must pay 100% of the total amount by bank transfer to the bank account indicated on the invoice.

Only in this case, upon receipt of 100% of the total amount, will the space be reserved for the exhibitor.

The organisation, provided that the reservation

has not been formalised, may allocate the space to a third party.

Only in this case, after payment of 100% of the total amount, will the exhibitor have the right to set up and occupy the reserved space.


Cancellations will not be accepted, and the organisation will not reimburse the amount paid under any circumstances.

- The structures must have their corresponding stabilization elements, whether ballast or otherwise, depending on the type of element.
- For complex assemblies, the exhibitor must submit the project documentation to the organization for approval in accordance with the regulations of the Kursaal Elkargunea Center.
- Stands with different heights must have structural elements to provide accessibility for people with reduced mobility.
- Internet service can only be provided by the organization.
- Vehicles not belonging to the organization are prohibited from parking on the fairgrounds during the entire event.



GENERAL INFORMATION

- Exhibitors will be allowed to begin booth set-up on Friday, November 21.
- No set-up will be allowed before Friday, November 21.
- Each exhibitor will be responsible for the reception of its own material. No warehouse or delivery center will be available.
- Dismantling will begin immediately after the end of the Expo on Saturday at 8:00 pm.
- As far as possible, the materials used in the construction and decoration of the stand must be fireproof.
- The construction must at all times respect the safety and evacuation rules of the building, if necessary, follow the instructions established by the security officer.
- The organizer is not responsible for security, so each exhibitor will be responsible for
 the safekeeping and surveillance of their belongings. However, the exhibition space
 will be closed to the public each day of the exhibition from 21:00h (closing time) until
 09:00h the next day, being duly guarded by security guards of Centro Kursaal
 Elkargunea.
- The exhibition and sale of products is limited to those derived from the commercial
 activity of the contracting company, being totally forbidden the subcontracting to
 third parties of the contracted spaces. If this commitment is breached, the
 organization reserves the right to request the withdrawal of the stand, in case of
 failure to do so, the organization may do so by charging the costs incurred by the
 withdrawal to the exhibitor.
- Exhibitors may not paste, place, or display advertisements anywhere on the premises, except in their booth. Likewise, he may only distribute advertising from his own stand and only in relation to his own goods.

- responsible for compliance with applicable regulations on advertising, being the organization exempt in any case.
- The exhibitor shall ensure that his stand is open to the public and properly attended during the entire time of the fair. Otherwise, the organization reserves the right to close the stand.
- At least 1 month prior to the event, the design of the space must be informed, sending plans, images and any other descriptive document. It is emphasized that the possible installation of structural elements must be reported.
- Exhibitors must comply with the accreditation and coordination of business activities protocols, as well as with the rules established by the responsible parties.
- In the event that the capacity is full, the organization will draw up a waiting list that will be governed by strict order of entry of applications.
- The present conditions are subject to Spanish law, the parties agree that any litigious matter will be resolved by the courts of Barcelona city.
- The signatories of the reservation document declare, by their signature, to be aware
 of the aspects and conditions of the collaboration, as well as declare to accept and
 agree with them.
- It must be informed at least 1 month in advance also possible extensions of electrical outlets and internet needs, reserving the organization the right to its viability.
- If the cancellation is not communicated 1 month in advance, the full amount of the invoice must be paid.

• Certain products have their advertising regulated, so the exhibitor will be solely
